3. **THIS COURT ORDERS** that Class Counsel legal fees, disbursements, interest and applicable taxes shall be paid from the settlement funds, pursuant to the terms of the Settlement Agreements.

4. **THIS COURT ORDERS** that an honorarium of \$2,000 is awarded to Daniel Bennett to be paid from the settlement funds.

5. **THIS COURT ORDERS** that this Order is contingent upon approval of the Lenovo Agreement.

6. **THIS COURT ORDERS** that any appeal from this Order be brought within 30 days of the date of this Order pursuant to Rule 61.04 of the *Rules of Civil Procedure* notwithstanding the suspension of procedural time periods pursuant to Ontario Regulation 73-20 made under subsection 7.1(2) of the *Emergency Management and Civil Protection Act*.
