1. **THIS COURT ORDERS** that the retainer agreements entered into with the proposed representative plaintiffs, Sheridan Chevrolet Cadillac Ltd., The Pickering Auto Mall Ltd.


and Fady Samaha, are hereby approved, pursuant to section 32(2) of the *Class Proceedings Act, 1992*.

2. **THIS COURT ORDERS** that a legal fee of \$116,000.00, plus disbursements of \$34,759.07, plus interest of disbursement of \$1,095.54, plus applicable taxes is awarded to Class Counsel with respect to the Settlement Agreement entered into between the Plaintiffs and Yazaki Corporation and Yazaki North America, Inc. (“Yazaki”), dated October 19, 2015 (the “Yazaki Settlement Agreement”);
3. **THIS COURT ORDERS** that the Class Counsel legal fees, disbursements, interest and applicable taxes be paid from the settlement funds, payable pursuant to the terms of the Yazaki Settlement Agreements.
4. **THIS COURT ORDERS** that this Order is contingent upon a parallel order being made by the Supreme Court of British Columbia, and the terms of this Order shall not be effective unless and until such an order is made by the Supreme Court of British Columbia.
