**Class Counsel Fee Approval –Bosch and Mitsubishi Electric**

**THIS MOTION** made by Class Counsel for an order approving the payment of Class Counsel legal fees and disbursements, was heard this day at Osgoode Hall, 130 Queen Street West, Toronto, Ontario.


**ON READING** the materials filed and on hearing the submissions of Class Counsel;

1. **THIS COURT ORDERS** that a legal fee of \$522,000.00, plus disbursements of \$27,139.23 (including interest), plus applicable taxes is awarded to Class Counsel with respect to the settlement agreements entered into with the following Defendants:
  - (a) Mitsubishi Electric Corporation, Mitsubishi Electric Automotive America, Inc. and Mitsubishi Sales Canada, Inc. dated March 2, 2018 (the “Mitsubishi Electric Settlement Agreement”); and
  - (b) Robert Bosch GmbH, Robert Bosch Inc., and Robert Bosch LLC dated June 26, 2018 (the “Bosch Settlement Agreement”).
2. **THIS COURT ORDERS** that the Class Counsel legal fees, disbursements, interest and applicable taxes be paid from the settlement funds, pursuant to the terms of the Mitsubishi Electric Settlement Agreement and Bosch Settlement Agreement.
3. **THIS COURT ORDERS** that this Order is contingent upon approval of the Mitsubishi Electric and Bosch Settlement Agreements and approval of Class Counsel legal fees, disbursements, interest and applicable taxes by the Supreme Court of British Columbia, and the terms of this Order shall not be effective unless and until such orders are made by the Supreme Court of British Columbia.
4. **THIS COURT ORDERS** that this Order is contingent upon approval of the Mitsubishi Electric and Bosch Settlement Agreements by the Superior Court of Quebec, and the terms of this Order shall not be effective unless and until such Orders are made by the Superior Court of Quebec.
