1. **THIS COURT ORDERS** that the retainer agreements entered into with the proposed representative plaintiffs, Sheridan Chevrolet Cadillac Ltd., The Pickering Auto Mall Ltd., and Fady Samaha are hereby approved, pursuant to section 32(2) of the *Class Proceedings Act, 1992*.



2. **THIS COURT ORDERS** that a legal fee of \$622,940.71 plus disbursements of \$26,557.57 (including interest), plus applicable taxes is awarded to Class Counsel with respect to the settlement agreement entered into with Mitsuba Corporation and American Mitsuba Corporation, dated February 19, 2019 (the "Mitsuba Settlement Agreement").

3. **THIS COURT ORDERS** that Class Counsel legal fees, disbursements, interest and applicable taxes shall be paid from the settlement funds, pursuant to the terms of the Mitsuba Settlement Agreement.
