Class Counsel Fee Approval – Mitsuba

THIS MOTION made by Class Counsel for an order approving the payment of Class Counsel legal fees and disbursements, was heard this day at Osgoode Hall, 130 Queen Street West, Toronto, Ontario.

ON READING the materials filed and on hearing the submissions of Class Counsel;

1. **THIS COURT ORDERS** that a legal fee of \$285,035.04, plus disbursements of \$3,628.96 (including interest), plus applicable taxes is awarded to Class Counsel with respect to the

settlement agreement entered into with Mitsuba Corporation and American Mitsuba Corporation dated February 19, 2019 (the "Mitsuba Settlement Agreement").

2. **THIS COURT ORDERS** that the Class Counsel legal fees, disbursements, interest and applicable taxes be paid from the settlement funds, pursuant to the terms of the Mitsuba Settlement Agreement.
3. **THIS COURT ORDERS** that this Order is contingent upon approval of the Mitsuba Settlement Agreement and approval of Class Counsel legal fees, disbursements, interest and applicable taxes by the Supreme Court of British Columbia, and the terms of this Order shall not be effective unless and until such orders are made by the Supreme Court of British Columbia.
4. **THIS COURT ORDERS** that this Order is contingent upon approval of the Mitsuba Settlement Agreement by the Superior Court of Quebec, and the terms of this Order shall not be effective unless and until such Orders are made by the Superior Court of Quebec.
