ON READING the materials filed and on hearing the submissions of Class Counsel;

1. THIS COURT ORDERS that the retainer agreements entered into with the proposed representative plaintiffs, Sheridan Chevrolet Cadillac Ltd., The Pickering Auto Mall, Fady Samaha, and NILRU Inc. are hereby approved, pursuant to section 32(2) of the *Class Proceedings Act*, 1992.

- THIS COURT ORDERS that a legal fee of \$112,592.03, plus disbursements of \$19,991.41 (including interest), plus applicable taxes is awarded to Class Counsel with respect to the settlement agreement entered into with Omron Corporation, Omron Electrics Co. Ltd, Omron Automotive Electronics, Inc. and Omron Automotive Technologies Inc. dated March 6, 2018 (the "Omron Settlement Agreement").
- THIS COURT ORDERS that the Class Counsel legal fees, disbursements, interest and applicable taxes shall be paid from the settlement funds, pursuant to the terms of the Omron Settlement Agreement.
- 4. THIS COURT ORDERS that this Order is contingent upon approval of the Omron Settlement Agreement and approval of Class Counsel legal fees, disbursements, interest and applicable taxes by the Supreme Court of British Columbia, and the terms of this Order shall not be effective unless and until such orders are made by the Supreme Court of British Columbia.
