THIS MOTION made by Class Counsel for an order approving the payment of Class Counsel legal fees and disbursements, was read this day at Osgoode Hall, 130 Queen Street West, Toronto, Ontario.

ON READING the materials filed and on reading the submissions of Class Counsel;

1. **THIS COURT ORDERS** that the retainer agreements entered into with the proposed representative plaintiffs, Sheridan Chevrolet Cadillac Ltd., Pickering Auto Mall Ltd., and Fady Samaha are hereby approved, pursuant to section 32(2) of the *Class Proceedings Act, 1992*.

2. **THIS COURT ORDERS** that a legal fee of \$244,522.36, plus disbursements of \$327,084.04 (including interest), plus applicable taxes is awarded to Class Counsel with respect to the settlement agreement entered into with T.RAD Co., Ltd. and T.RAD North America Inc., dated July 20, 2017 (the "T.Rad Settlement Agreement").
3. **THIS COURT ORDERS** that the Class Counsel legal fees, disbursements, interest and applicable taxes shall be paid from the settlement funds, pursuant to the terms of the T.Rad Settlement Agreement.
4. **THIS COURT ORDERS** that this Order is contingent upon approval of the T.Rad Settlement Agreement and approval of Class Counsel legal fees, disbursements, interest and applicable taxes by the Supreme Court of British Columbia, and the terms of this Order shall not be effective unless and until such orders are made by the Supreme Court of British Columbia.
5. **THIS COURT ORDERS** that this Order is contingent upon approval of the T.Rad Settlement Agreement by the Superior Court of Quebec, and the terms of this Order shall not be effective unless and until such an Order is made by the Superior Court of Quebec.
